MAY 27, 2012	DH MESSAGES WITH BRITTNEY ON FACEBOOK ABOUT DH'S REPORT OF SEXUAL ABUSE BY DONNIE, SCOTT, AND DUSTIN KENT.
MAY 27, 2012, 8:03 PM	DH SHARES A POST ON FB ABOUT SWIMMING WITH HER BROTHERS AND HOW MUCH SHE'D MISSED THEM. SHE THANKS RELATIVES FOR LETTING HER STAY WITH THEM.

MAY 30, 2012	DH SENDS MESSAGE TO BRITTNEY THAT GOES UNANSWERED.
MAY 30, 2012	BRITTNEY EXCHANGES TEXTS AND CALLS WITH VARIOUS FAMILY MEMBERS AND FRIENDS
MAY 30, 2012	BRITTNEY TELLS FAMILY MEMBERS THAT SHE IS GOING TO STYX RIVER TO VISIT DONNIE. SHE LEFT ON FOOT, AND FAMILY MEMBERS BELIEVE SOMEONE PICKED UP HER BUT DON'T KNOW WHO.
MAY 30, 2012	ACCORDING TO CHESSIE, BRITTNEY WAS ACTIVE ON FACEBOOK THE EVENING OF MAY 30. IF THAT ACTIVITY WAS ON BRITTNEY'S PERSONAL FACEBOOK PAGE, THAT ACTIVITY IS NO LONGER VISIBLE TO THE PUBLIC.
MAY 30, 2012, EVENING	WENDY SHARES STATUS ON FACEBOOK ABOUT HER CHILDREN AND RESPONDS TO COMMENTS AT 7:33 PM AND 9:46 PM. HER LOCATION IS SHOWN AS TURKEY BRANCH.
MAY 31, 2012, EARLY MORNING	WENDY SHARES STATUS ON FACEBOOK THAT ONE OF THE CHILDREN IS RUNNING A FEVER AND SHE'S HAVING TROUBLE SLEEPING. COMMENTS ARE LEFT BEGINNING AROUND 4:00 AM. HER LOCATION IS AGAIN SHOWN AS TURKEY BRANCH.
JUN 1, 2012	JUST BEFORE HIS SCHEDULED MEETING WITH BCSO INVESTIGATIONS, DONNIE IS LOCATED WITH A SELF-INFLICTED GSW TO THE HEAD.
JUN 2, 2012, 6:17 AM	CHESSIE SHARES A POST ON FACEBOOK THAT DONNIE WAS STILL HANGING ON AND THAT SHE WAS HEADED BACK TO BE WITH HER SISTER. SHE ADDS THAT SHE IS WORRIED ABOUT BRITTNEY BECAUSE SHE HASN'T BEEN ABLE TO GET IN TOUCH WITH HER AND ASKED ANYONE WHO SPOKE TO HER TO TELL HER TO CALL HER MOM IMMEDIATELY.
JUN 2, 2012, 4:30 PM	CHESSIE REPORTS BRITTNEY MISSING TO MPD. THE LOCATION OF OCCURRENCE IS LISTED AS CHESSIE'S HOME.
JUN 4, 2012	DONNIE SUCCUMBS TO THE INJURIES SUSTAINED.
JUN 4, 2012, 11:21 PM	CHESSIE SHARES A POST ON FACEBOOK AND ASKS FOR HELP IN LOCATING BRITTNEY. SHE SAYS IT HAS BEEN 5 DAYS SINCE SHE WAS LAST HEARD FROM. SHE ALSO ADDS THAT DONNIE HAS PASSED AWAY.
JUN 7, 2012	MEDIA OUTLETS REPORT THAT BRITTNEY TOLD FAMILY MEMBERS SHE WAS HEADED TO THE STYX RIVER AREA TO VISIT HER UNCLE, DONNIE.
JUN 6-7, 2012	BALDWIN COUNTY DEPUTIES SEARCH AREA AROUND WATERWORLD RD., BRITTNEY'S LAST KNOWN LOCATION.
JUN 8, 2012	BCSO SAYS THEY'VE FOUND NOTHING TO INDICATE BRITTNEY IS IN BALDWIN COUNTY.

JUN 8, 2012	MENDY SHARES ON FACEBOOK THAT WENDY AND THE KIDS SPENT THE NIGHT OF MAY 31ST WITH DONNIE AT THE STYX RIVER HOUSE. THE MORNING OF JUNE 1, DONNIE DROPPED WENDY AND THE KIDS OFF AT A FRIEND'S AND THAT WENDY FOUND DONNIE ABOUT AN HOUR AND A HALF LATER WITH THE GSW.
JUN 11-15, 2012	KLAAS KIDS FOUNDATION JOINES THE SEARCH EFFORT. VOLUNTEERS SEARCHED A 5-MILE AREA AROUND THE WATERWORLD HOME WHERE BRITTNEY WAS LAST BELIEVED TO BE. ADDITIONAL AGENCIES JOIN THE SEARCH EFFORT.
JUN 11, 2012	CHESSIE DOES AN INTERVIEW WITH JANE VELEZ-MITCHELL AND SAYS BRITTNEY WAS GOING TO HER FRIEND KOURTNEY'S AND SHE BELIEVED KOURTNEY WAS PICKING HER UP.
JUN 16, 2012	REVIEW OF BRITTNEY'S CELLPHONE RECORDS REVEAL HER LAST PING WAS IN GRAND BAY. SEARCH EFFORTS MOVE TO THAT AREA.
JUN 19, 2012	DUSTIN KENT ARRESTED IN BALDWIN COUNTY ON CHARGES OF FIRST-DEGREE SODOMY AND SECOND-DEGREE RAPE
JUN 19, 2012	SCOTT WOOD ARRESTED IN BALDWIN COUNTY ON CHARGES OF SECOND-DEGREE SEX ABUSE, SECOND-DEGREE SODOMY, AND INCEST.

JUL 22, 2012	BILLY BROWNLEE ARRESTED ON CHARGES OF SECOND-DEGREE SODOMY AND SECOND-DEGREE SEX ABUSE IN BALDWIN COUNTY.
JUL 23, 2012	ACCORDING TO FOX10, FAMILY MEMBERS SAY BRITTNEY WAS LAST SEEN HEADING TO BALDWIN COUNTY AND THE STYX RIVER AREA WITH DONNIE.
AUG 2, 2012	DUSTIN KENT ARRESTED ON CHARGES OF FIRST-DEGREE RAPE AND FIRST-DEGREE SODOMY IN MOBILE
AUG 22, 2012	WENDY HOLLAND ARRESTED IN BALDWIN COUNTY ON A CHARGE OF ENDANGERING THE WELFARE OF A CHILD
NOV 19, 2012	KLAAS KIDS SEARCHES 30-ACRE AREA IN TILLMAN'S CORNER
NOV 29, 2012	NEW CHARGES ISSUED IN WENDY'S BALDWIN COUNTY CASE - FIRST-DEGREE SODOMY, SEXUAL TORTURE AND SEX ABUSE.

DEC 17, 2012	CHESSIE ALONG WITH BRAD DENNIS FROM KLAAS KIDS HOLD A PRESS CONFERENCE ASKING HUNTERS TO KEEP A LOOKOUT FOR ANY SIGN OF BRITTNEY.
JAN 26, 2013	BRITTNEY'S FAMILY HOLDS A VIGIL FOR HER AS WELL AS OTHER MISSING PERSONS.
APR 29, 2013	ERIC WINBERG CONFIRMS TO FOX10 THAT INVESTIGATORS BELIEVE BRITTNEY WAS ALSO A VICTIM AND WERE LOOKING TO TALK TO HER PRIOR TO HER DISAPPEARANCE. CHESSIE TELLS FOX10 THAT SHE BELIEVES BRITTNEY WENT TO CONFRONT DONNIE OVER THE ALLEGATIONS AND SOMETHING WENT TERRIBLY WRONG.
JUN 27, 2013	CHESSIE ARRESTED IN MOBILE COUNTY ON CHARGES OF SODOMY AND CHILD SEX ABUSE.
OCT 8, 2013	BAYOU LA BATRE PD ARRESTS BROWNLEE AND TWO OTHERS UNRELATED ON CHARGES OF FIRST-DEGREE CRIMINAL MISCHIEF AND SECOND-DEGREE BURGLARY AFTER BROWNLEE WAS DISCOVERED STEALING SEVERAL STAINLESS STEEL PIPES FROM A BUSINESS.
OCT 21, 2013	BROWNLEE ARRESTED ON AN UNRELATED RAPE CHARGE INVOLVING AN UNRELATED MINOR.
OCT 22, 2013	NEW CHARGES ISSUED IN DUSTIN'S MOBILE COUNTY CASE - FIRST-DEGREE RAPE, FIRST-DEGREE SODOMY, PRODUCTION OF OBSCENE MATTER OF A PERSON UNDER 17, AND SEX ABUSE OF A CHILD LESS THAN 12.
OCT 22, 2013	SCOTT ARRESTED IN MOBILE COUNTY ON CHARGES OF SECOND-DEGREE RAPE, SECOND-DEGREE SODOMY, AND ENTICING A CHILD INTO A BUILDING OR DWELLING.
OCT 22, 2013	BROWNLEE ARRESTED ON CHARGES OF FIRST-DEGREE SODOMY, SEX ABUSE OF A CHILD LESS THAN 12, AND TWO COUNTS OF FIRST-DEGREE RAPE IN MOBILE COUNTY.
OCT 22, 2013	WENDY ARRESTED ON CHARGES OF SECOND-DEGREE SODOMY IN MOBILE COUNTY
OCT 22, 2013	MENDY ARRESTED IN MOBILE COUNTY ON CHARGES OF SECOND-DEGREE SODOMY AND SEX ABUSE OF CHILD LESS THAN 12.
OCT 22, 2013	NELTON "BUTCH" MORGAN ARRESTED IN MOBILE COUNTY ON CHARGES OF FIRST-DEGREE RAPE AND SEX ABUSE OF A CHILD LESS THAN 12.
OCT 22, 2013	JAMES CUMBA ARRESTED IN MOBILE COUNTY ON CHARGES OF FIRST-DEGREE RAPE, FIRST-DEGREE SODOMY, AND SEX ABUSE OF A CHILD LESS THAN 12.

OCT 29, 2013	CHESSE TELLS AL.COM SHE BELIEVES DONNIE KILLED BRITTNEY DURING A CONFRONTATION, AND SHE BELIEVES WENDY KNOWS WHAT HAPPENED.
NOV 1, 2013	JENNIFER MOORE ARRESTED IN BALDWIN COUNTY ON CHARGES OF SECOND-DEGREE SEXUAL ABUSE AND PRODUCTION OF CHILD PORNOGRAPHY.
NOV 17, 2013	AUTHORITIES EXECUTE SEARCH WARRANT AT BRITTNEY'S HOME BUT WOULD NOT PROVIDE A REASON FOR THE WARRANT OR THEIR FINDINGS. THEY ALSO EXECUTED A SEARCH WARRANT AT WENDY'S IRVINGTON HOME AND RECOVERED ELECTRONIC DEVICES BELIEVED TO HOLD CHILD PORNOGRAPHY.
NOV 19, 2013	AUTHORITIES CONFIRM THEY BELIEVE BRITTNEY'S DISAPPEARANCE IS LINKED TO THE ONGOING SEX ABUSE INVESTIGATION.
JAN 1, 2014	KLAAS KIDS ALONG WITH VARIOUS LAW ENFORCEMENT AGENCIES SEARCH 5 ACRES IN THEODORE BUT FIND NOTHING RELATED TO BRITTNEY.
