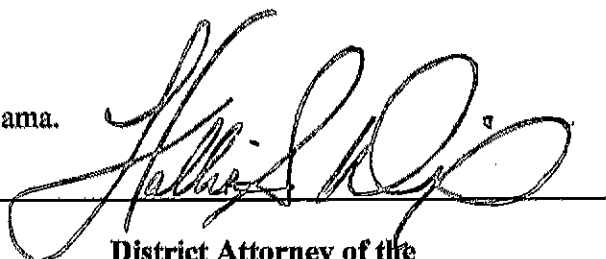

Bail is fixed in the amount of \$10,000 on Count I of the indictment and \$25,000 on Count II of the indictment.

CONDITIONS OF BOND

The Defendant is ordered to (a) appear, answer and submit to the orders of the Court having jurisdiction of the case; (b) refrain from committing any criminal offense; (c) not depart from the State of Alabama without leave of the Court; and (d) promptly notify the Court of any change of address.

The Defendant is further ordered:

- a. Defendant's bond shall be approved by the Sheriff.
- b. Defendant shall have no contact with the victims and/or the victims' family.
- c. Defendant shall not be within one mile of the victim's residence(s);
- d. Defendant shall not have any contact with any child under the age of 18.
- e. You are under house arrest and are not to leave your listed address without prior approval of the Court EXCEPT for work at a legitimate place of business, church, medical emergency, attorney visit or court appearance, all of said exceptions must be approved by the ankle monitoring agency.
- f. You must sign up for and comply with all conditions of electronic monitoring within twenty-four (24) hours, or not later than the next working day, after release from jail. The Sheriff may release the defendant on bond upon receiving confirmation from the electronic monitoring agency that the defendant has satisfied all requirements for electronic monitoring other than being hooked up to the system. Additionally, within twenty-four (24) hours of his/her release, the Defendant shall provide the Court and the District Attorney with documented confirmation of Defendant's compliance with the electronic monitoring agency. The Court and the District Attorney shall be notified immediately by the electronic monitoring agency of the defendant's failure to comply with this condition of his/her bond and failure to comply with this condition of hi/her bond may be grounds for the Court to revoke the defendant's bond.
